THE MORATORIUM ON EVICTIONS AND FUTURE OF RENT PROTECTIONS

Michael McKee, leader of Tenants PAC—a group supported by the LTTA—says there is a moratorium on all evictions until March 1. The landlord cannot file a lawsuit against you for non-payment of rent, nor can previously-filed cases move forward.

You can file a hardship declaration stating that you are either 1) unable to pay your rent on time due to financial troubles and/or 2) cannot be evicted due to COVID health concerns.

That will prevent procedure against you until May 1.

The push of the tenant movement in Albany right now is rent relief for tenants in need.

Some federal relief is in the pipeline but it won't be enough. Legislative leaders want to raise taxes on the wealthy, but Governor Cuomo hasn't expressed his support. We remain concerned about retaining our hard-won tenant protections. The survey that will determine whether the citywide vacancy rate has exceeded 5% (at which point the law says the rent emergency is over and the laws disappear) will be conducted this year and the results released by January. Manhattan vacancies are much higher due to the pandemic, but lower in the other boroughs. Given the pandemic, we're looking at requiring the 5% threshold to be reached in two consecutive surveys to help avoid undoing the laws. Get more info on Tenants PAC at **TenantsPAC.org**

From the office of State Senator Brad Hoylman:

"As State Senator for Manhattan, Brad Hoylman has championed a wide range of progressive issues, such as housing, mass transit & safe streets, public education, LGBTQ rights, the environment and seniors. He has passed over 70 bills in the Senate, including the Child Victims Act, allowing adult survivors of child sexual abuse to revive legal claims against their abusers; the TRUST Act, which permitted Congress to review the state taxes of elected officials such as Donald Trump; GENDA, which extended human rights protections to transgender New Yorkers; banning the practice of sexual orientation change efforts on children, or so-called "conversion therapy;" and the Tenant Safe Harbor Act, which prevents tenants from being evicted if financially impacted due to COVID-19."

LTTA has hosted a number of ZOOM conference video calls with our elected officials, including: US Representative Jerry Nadler, State Senator Brad Hoylman, Speaker/Council Member Corey Johnson, NYC Comptroller, Scott Stringer, Borough President Gale Brewer, Assembly Member Richard Gottfried. WHY WE HAVE TO KEEP STAIRCASES FREE OF OBSTRUCTIONS AND DEBRIS

Tenants are piling up their boxes, bags, and even furniture on the landings that are strictly meant to be fire escapes in emergencies and blackouts. There are rules and guidelines we all have to follow:

= If it does not fit, take it to the basement.

If you have something that won't fit down the chute or into the recycling bags, bring it to the basement and place on either side of the elevator door.

If you need help disposing something, call the maintenance office for removal: 212-243-7000 x3

- = Rinse recyclables, reduce roaches.

 Before placing plastic or glass food containers in the recycling bag, rinse out the attractive smell of food.
- **= Please don't misuse our common space.** For instance, a tenant in the 450 building shakes out rugs on the staircase. This health and safety hazard is illegal. Please be safe *and* considerate.
- = Hallways can't be used to store things.
 It may be convenient, but mats, bicycles, strollers, shoes, etc. can't be stored in the hallways. It's all about keeping the hallways clean and eliminating fire hazards and you won't know how important that is until we need to exit in the event of a fire or blackout.

NEIGHBOR GLORIA SILVERMAN DIES

A 60-year resident of London Terrace Gardens in 425/16-A for 60 years, Gloria died on January 3rd. She was 93 years old. "She loved life and loved living in London Terrace," said her daughter Jill, who was herself born here. "It's a shame that COVID took her life. Even in the hospital she said, 'I'm not ready to leave." Gloria had beaten cancer on six different occasions. Jill said her mom was a Radio City Music Hall Rockette in the 1950s and in the Broadway cast of "Oklahoma." She was a model in the 1960s. "Everyone knew her and loved her," Jill said. "She had a positive energy about life."
